## BOARD UPDATES

For several years IAHSE has organized the agency Directors' meeting during Latino Unity Day. One of the recommendations from the IAHSE board to the state agencies was to increase the number of bilingual supervisors in state government. Supervisors play an important part in state government from addressing public concerns to advising and implementing government policy. One agency reviewed our recommendation.

The Illinois Department of Employment Security (IDES) went back after the discussions and conversations with IASHE and created four new bilingual Spanish speaking Field Officer Supervisors. There are now two in the Pilsen Local Office, one in the Springfield Call Center and one in the Peoria Local Office.

Before creating and hiring these four Spanish speaking positions, IDES did the same with IAHSE and previous recommendation from the Hispanic Employment Plan Advisory Council, i.e., to create and hire bilingual auditors in our Revenue Division. To quote IDES "This exemplifies the power of partnership between IAHSE and State agencies. We truly appreciate your support and guidance as we navigate the best ways to create access for those in the communities we serve." The IASHE board members appreciate the effort put forth by the Illinois Department of Employment Security to acknowledge the need for more bilingual supervisors in state government.

## LEGISLATIVE UPDATES

On June 25, 2024 Governor Pritzker signed Senate Bill 1 creating a new cabinet-level state agency dedicated to early childhood education and development.

Senate Bill 1, now Public Act 103-0594, states: "It is the purpose of this Act to provide for the creation of the Department of Early Childhood and to transfer to it certain rights, powers, duties, and functions currently exercised by various agencies of State Government. The Department of Early Childhood shall be the lead State agency for administering and providing early childhood education and care programs and services to children and families. This Act centralizes home-visiting services, early intervention services, preschool services, child care services, licensing for day care centers, day care homes, and group day care homes, and other early childhood education and care programs and administrative functions historically managed by the Illinois State Board of Education, the Illinois Department of Human Services, and the Illinois Department of Children and Family Services. Centralizing early childhood functions into a single State agency is intended to simplify the process for parents and caregivers to identify and enroll children in early childhood services, to create new, equity-driven statewide systems, to streamline administrative functions for providers, and to improve kindergarten readiness for children."

Furthermore, Section 80-5(b) of the Act states: "(b) Personnel employed by the Department of Human Services or the Department of Children and Family Services who are engaged in the performance of functions transferred to the Department or who are engaged in the administration of a law the administration of which is transferred to the Department shall be transferred to the Department of Early Childhood. The status and rights of the employees and the State of Illinois or its transferring agencies under the Personnel Code, the Illinois Public Labor Relations Act, and applicable collective bargaining agreements, or under any pension, retirement, or annuity plan, shall not be affected by this Act.

On August 2, 2024 Governor JB Pritzker signed SB376, the Language Equity and Access Act, into law. The bill requires the Governor's Office of New Americans (ONA), in partnership with the Illinois Department of Human Services (IDHS), to craft, implement and oversee statewide language access requirements. The legislation seeks to ensure that language proficiency is not a barrier for Illinoisans seeking to access state agency resources. The legislation requires ONA and IDHS to prepare a Language Needs Assessment Report to be updated every 10 years in order to assist State agencies in the creation of language access plans for state resources. The ONA will also provide oversight and central coordination to State agencies in the implementation of language access requirements and ensure that each State agency develops an internal complaint and review process specific to the provision of language assistance services in addressing complaints in a timely manner. The Act, which is effective immediately upon signing, also includes a requirement of an annual compliance report to the Governor's Office and the Illinois General Assembly.
