## **LEGISLATIVE UPDATE**

HB 1563 was signed by Governor Pritzker Amending the CMS Services Law of the Civil Administration Code to remove the preference for location of jobs in Sangamon County. The legislation instructs CMS Director: "to determine a geographic location for each State employment position taking into consideration a variety of factors, including, but not limited to the nature or function of a position, whether the position is well-suited for telework or a similar arrangement, where a diverse and equitable applicant pool exists, the preference for State employment positions to be located in Sangamon County, and other similar factors that should determine the geographic location of a State employment position."
