LEGISLATIVE UPDATE

On Tuesday, October 24, Governor Pritzker made an announcement regarding a proposal to establish a new state agency responsible for consolidating all early childhood programs and funding. To kick off this multi-year process, Governor Pritzker has signed an Executive Order and will collaborate with the General Assembly on crafting legislation in the spring of 2024.

This newly formed agency will bring together the following programs into a single agency:

- The Early Childhood Block Grant at ISBE, which provides funding for programs such as Preschool for All and the Prevention Initiative home-visiting program.
- The Child Care Assistance Program, Home-Visiting, and Early Intervention services at DHS.
- Daycare licensing, which is currently managed by DCFS.

We strongly encourage our members working within the affected agencies and programs to contact their collective bargaining union on the implications of this executive order.

HISPANIC STATE EMPLOYEES WORKFORCE UPDATE

As of the end of August, the total number of Hispanics subject to the Personnel Code is approximately 45,319. Hispanic employees represented about 7.5% of the total code employees (3,389). It is worth noting that there are approximately 6,640 veterans employed in code positions which includes 324 Hispanic veterans. The number of Hispanics receiving bilingual pay is approximately 1,409.
