BOARD UPDATES

Thank you to all members who participated in the election of our board members. We are pleased to announce that all candidates were re-elected to continue serving on the IAHSE board.

In our most recent board meeting, new executive committee members were appointed. Diane Casas has been named President, Edwin Sanchez Molina will serve as Vice President, and Gianni Serrano has been appointed Secretary.

We extend our gratitude to the new executive committee for their commitment to advancing IAHSE's mission. Together, we will continue advocating for increased representation of Hispanic (Latino/a/e/x) individuals in state government.

FY 24 BILINGUAL NEEDS & PAY REPORT

The annual Bilingual Needs/Bilingual Pay was filed in January with the general assembly. CMS conducted their annual Employment Plans/ BNPB Survey was conducted from August 12, 2024, through September 13, 2024, and received responses from 50 agencies. Participants based responses on FY24 data – July 1, 2023, through June 30, 2024. Fifty out of 65 state agencies responded to the survey. The workforce grew by nearly 7% from the end of FY23 to the end of FY24, reaching a population of more than 51,000 employees. The workforce excludes employees from other constitutional offices.

Nineteen agencies combined to post 465 bilingual positions in FY24 with 84% (391 positions) of the posted bilingual positions required Spanish language skills. There 2,028 Code-covered employees in the State receiving bilingual pay, 78.8% (1,598) of them were employed to use their Spanish language skills in serving the people of Illinois. Another nearly 16% (316) of bilingual employees are employed to serve those who use American Sign Language. The remaining 114 employees are split between Polish (41) and various other languages (73). HISPANIC EMPLOYMENT PLAN ADVISORY COUNCIL UPDATE

The Employment Plan Advisory Council met on December 5, 2024. The Illinois Department of Central Management Services provided an update on the "Success Factors" hiring process. From January to November 2024, CMS received over 126,000 applications, including 13,697 from Latinx individuals (11%). On average, it took 104 days from job posting to onboarding.
